R.O.C. overseas missions shall process foreign professionals' employment-seeking visa applications after verifying that all required documents have been submitted. If a review of the application raises no concerns, the R.O.C. overseas mission shall issue a multiple-entry visitor visa to the applicant that is valid for three months and allows for a stay in Taiwan of up to six months.

If concerns exist regarding the applicant's eligibility following review of the application, it shall be transferred to the Ministry of Foreign Affairs, which shall request that the competent central authority assist in reviewing the applicant's eligibility.

**Article 5**

With regard to eligibility criteria and required documents for residents of Hong Kong or Macao who are applying for an employment-seeking entry and exit permit, the provisions of Article 2 and Subparagraphs 4 to 10 of Paragraph 1 of Article 3 of the Regulations shall be followed.

**Article 6**

The Regulations shall enter into force on October 25, 2021.
